Our gardens are living examples of excellence in horticulture

What do you love most about your RHS Garden Rosemoor? Is it the Cottage Garden, the Woodland or perhaps the stunning Hot Garden, with its reds, yellows, oranges and purples?

Behind the scenes we research how best to cultivate plants and protect them against pests and diseases, garden sustainably in a changing climate and encourage biodiversity.

Our education programmes for children engage them with the natural world of the garden, and our training of new horticulturists and apprentices means we are securing the future.

Our gardens have an illustrious history, rooted in the vision of their founders. Scientist George Fergusson Wilson created Wisley with the ambition to make 'difficult plants grow successfully'.

Lady Anne Palmer filled her collection at Rosemoor with plants drawn from as far afield as Brazil and Japan; while Dr and Mrs Robinson turned a windswept hill at Hyde Hall into a green oasis. Finally, Harlow Carr, originally founded as a spa in 1840 by Henry Wright became ours in 2001. Our newest garden, RHS Garden Bridgewater, near Manchester, will open in 2019.

Since these exceptional gardens have been in our care we have pushed the boundaries in design, ideas and techniques, enriching the lives of so many people.

Suggested wording for leaving a legacy to the RHS

We recommend seeking legal advice when making or updating your Will.

If you leave a gift in your Will to a charity, like the RHS, the gift is exempt from inheritance tax. Your solicitor will be able to offer you further advice and guidance on efficient tax planning.

When leaving such gifts, you can elect to give the gift to the general funds of the charity, or to a specific activity; for the RHS, this could be to a specific garden. We have reflected such choices in the suggested wording below.

1. Leaving the residue of your estate to the RHS:

This is when you leave the residue of your estate after all other gifts, costs and so on have been deducted. This type of gift allows for the remainder of your estate (or a specified percentage of it) to be passed to the RHS.

You may leave the residue to one person or organisation, or you can divide it among any number of beneficiaries. The value of this type of gift will increase as the value of your estate increases.

You might want to use the following wording:

I leave to the Royal Horticultural Society (registered charity number 222879/SCO38262) of 80 Vincent Square, London SW1P 2PE ("all" or state fraction) of the residue of my estate absolutely for ("its general purposes" or, for example, "for its garden at Rosemoor") and direct that the receipt of an authorised officer of the said charity shall be good and sufficient discharge to my executors.

2. Pecuniary or fixed amount legacy:

When you want to leave a specific or fixed amount of money. Over the course of time, this type of gift is likely to lose value because of inflation. You may therefore wish to consider index linking your cash gift.

I leave to the Royal Horticultural Society (registered charity number: 222879/SCO38262) of 80 Vincent Square, London SW1P 2PE absolutely the sum ₤... for ("its general purposes" or, for example, "for its garden at Rosemoor"). I declare that the receipt of an authorised officer shall be good and sufficient discharge to my executors.

Or, if you wish to secure the value of your gift against the effects of inflation:

I leave to the Royal Horticultural Society (registered charity number: 222879/SCO38262) of 80 Vincent Square, London SW1P 2PE absolutely for ("its general purposes" or, for example, "for its garden at Rosemoor") the sum of money produced by dividing the sum of €... by index figure in the Index of Retail Prices ('the index') for the month in which this will be executed and multiplying it by the index figure in the index month in which my death occurs. I declare that the receipt of an authorised officer shall be good and sufficient discharge to my executors.

3. Leaving a specific item

A gift of specific property such as antiques, shares or paintings. The Item(s) must be clearly described in your Will to avoid any possible confusion and to ensure the gift does not fail.

Your solicitors will be able to prepare appropriate wording for your Will.

4. If you want to change your existing Will

You can easily add a gift to the RHS to your existing Will using a short document called a Codicil. Your solicitor will advise you how to do this so that no legal or technical mistakes occur.

No matter whether your gift is large or small, the RHS is extremely grateful for your support.

5. A reversionary legacy

This is the means of leaving a gift to a chosen beneficiary such as the RHS, whilst meanwhile allowing another person to have the use of it during his or her lifetime.

For example, you may want someone to have the use of your home for the remainder of his or her life, or of the income from a fund. When s/he dies, the item will then pass to the RHS.

Your solicitors will be able to prepare appropriate wording for your Will.

Frequently Asked Questions

Why does the RHS need legacies?

Gifts in Wills provide vital income to the RHS. As a charity we receive no government support and much of our work can only continue through additional funding, including legacies. For every pound we raise from member subscriptions, we need to raise another pound by other means to fund our charitable work.

Can I choose where you spend my legacy?

Yes, you can specify how your money is spent, such as a gift to RHS Garden Rosemoor, or to our Campaign for School Gardening. However leaving a gift for us to use in the way that allows us the most flexibility, means that we can use funds where they are most needed.

Can I be sure that you will spend my gift where I want it to be spent?

We will endeavour to spend your gift as you have requested. However in some circumstances where there are very specific terms attached to your legacy, we may not be able to spend or accept it if the terms do not fall under our remit of work. We do therefore ask if you intend to leave your gift for a very specific purposes that you discuss it with us so that we can ensure we will be able to carry out your wishes.

What are the inheritance tax implications of leaving a legacy?

The RHS is a charity and money left to a charity is exempt from inheritance tax. Your solicitor will advise you if you could be liable to pay inheritance tax on your estate and can suggest ways of minimising your liability. How do I make a Will?

A valid Will is the only guaranteed way for your wishes to be carried out. Making a Will isn't complicated and shouldn't be costly. We strongly recommend that you seek legal advice when you prepare your Will.

Can the RHS be one of my executors?

Unfortunately, the RHS is unable to act as an executor. We recommend that you choose two executors, who can be a professional advisor, family member or friend. Your solicitor will advise you as to the eligibility of a chosen executor.

Can I choose how much I want to leave and does it have to be for a lot of money?

You can specify exactly how much you would like to leave to the RHS and no, it doesn't have to be a lot of money; any contribution towards supporting our work is hugely appreciated.
